Experian Pandora provides interactive functionality to:

Experian Pandora provides three main functions; Data Analysis, Data Prototyping and Data Management.

Data Analysis provides data transparency at an enterprise level. It allows data architects and subject matter experts to investigate and assess data content, structure, relationships and quality. Experian Pandora provides unlimited speed of thought browsing and interrogation of data and metadata. The single, consolidated repository of knowledge

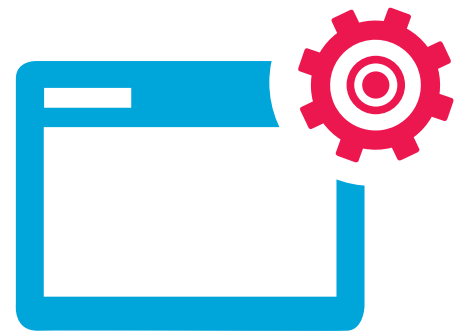
about data will underpin all subsequent data-dependent projects.

Data Prototyping allows Data Architects and Analysts to generate complete, optimised, unambiguous and fully validated mapping specification documents for end-to-end data integration processes, along with full sets of associated test data.

Data Management enables organisations to identify and investigate relevant data, assess and improve its quality, and control this process over time, independent of whether the information concerns customers, products, finance, sales or other business areas. Business rules are associated with monetary measures to provide business relevant financial KPIs, and their results are stored to provide time-based directional KPIs.

Determine the status of your data

Fully understanding your starting point will underpin all subsequent work on the project. Simply point Experian Pandora at all potentially relevant sources of data – databases or spreadsheets – and it will automatically analyse them, providing rich insight into its content and structure. The Platform uses statistical analysis to automatically highlight possible issues across all your source systems and can provide conclusive identification of all relevant data. You can also document your investigations, findings and conclusions directly within Experian Pandora.

Establish a common vocabulary

Your team can analyse and define the business meaning of each of the data items discovered, a requirement of most Data Governance work. They will immediately identify all places containing a particular type of data and group them together under a common definition.

Apply your own quality measures

Insert your business's own data quality rules and weight the scores according to their importance to the profitability of your business. Rules are consistently applied across all data from all systems.

Remediate, or not

Use Experian Pandora to specify and validate your data correction rules, and generate a document which details the rules you applied in order to produce the corrected data. If you decide not to remediate, you can document this fact with the justification in the Platform for future reference.

Monitor data quality

Define and apply your own data quality measurement rules, and automatically produce standard dashboards with data quality Key Performance Indicators over time to monitor progress.

Build data movement processes

Using Experian Pandora's graphical design tool, specify and prototype the processes used to populate any system.

Data may have to be transformed, enriched or cleaned up, or perhaps matched to external and historical data. Prototyping makes the process easy - results of the transformations can be viewed and validated on-the-fly. Experian Pandora remembers everything you have done to the data, resulting in transparent reporting. In many cases, you can even use Experian Pandora to execute the data movement processes.

Provide an audit trail

Whether you want to show that your analysis is diligent, your calculations are based on the correct information, your terminology is consistent, or your data quality processes are effective, Experian Pandora provides the necessary information. Show, for example, all the logic applied to the data to build a data warehouse and access the actual data and associated project notes used to define those data load processes.

Report

Immediately answer ad-hoc questions about the project, its processes and its data, whether from the business or from auditors/regulators.
