How it works

Experian Data Quality functionality is available at address capture touch points

within the Episys core. Users modified member addresses as usual, typing directly into the system. As staff tab out of the ZIP Code[™] field, the Experian Data Quality tool is automatically invoked.

In most situations, the Experian Data Quality tool will verify and standardize the address in real time, with no user interaction. When user interaction is required to locate a verified match, the user will be directed to the verification page. On this page, users will be prompted to enter the missing address components.

Integration specifications

Enabling Experian Data Quality address verification takes, on average, 1 hour. Installation documentation and timelines relate to all standard address capture touch points.

To access the functionality, install the "QAS" Specfile (provided by Experian Data Quality) on the Episys Server and create a new standard RepGen. Install QAS Pro Web and a Java Web Server on a general application server. Once the installation is complete and the qasSymitar.war file is stored within the WebApps directory on the web server, restart the Experian Data Quality service to enable the new functionality.
