Thrive under the GDPR

Before embarking on any data related project whether that be a migration, analysis or the implementation of a data governance strategy, the natural first step is to assess your data; its quality and integrity. Many data related projects fail to realise their intended benefit because decisions are made based on inaccurate or irrelevant data. Failure in the context of the General Data Protection Regulation (GDPR) could be catastrophic for any organisation.

The EU General Data Protection Regulation contains specific requirements for organisations to ensure that the personal data they hold is accurate and that the collection, storage, use and erasure of this data follow a Privacy by Design approach.

In order to prepare your organisation for the GDPR, Experian believe that creating this Privacy by Design approach and honouring the accountability principle are key to success. The Data Integrity Service from Experian will enable you to discover and prioritise the risks hidden within personal data.

The Data Integrity Service can help highlight risks to maintaining compliance in the long-term such as:

What is the service?

Data Integrity Assessment

The quality of data is assessed by checking data accuracy and integrity.

Data accuracy: accuracy of data against Experian reference sets is established and data duplication is measured. This provides your GDPR program with a quantitative understanding of the accuracy principle risk.

Data integrity: quality attributes such as uniqueness, completeness, frequency of values and formats are combined with the earlier accuracy scores to understand the relationships between data and the gaps. As with data accuracy, this assessment can be used by your GDPR program to understand the challenges that may occur in areas such as Data Access, Erasure and Portability.

GDPR as business as usual

Whilst helping your organisation prioritise their immediate actions for the GDPR, the Data Integrity Service can be offered on a repeatable basis to ensure that data issues are identified and tackled on an on-going basis as part of a Privacy by Design data management strategy. This regular data quality reporting can be crucial at times such as:

- Planning changes to website marketing consent pages
- Call centre or CRM application updates
- Internal or external audits of GDPR compliance

In short, maintaining data quality over time will be of critical importance in order to demonstrate accountability and maintain consumer trust.
